

# **CHANGE OF NAME**

## OVERVIEW

Circuit courts have jurisdiction to change the name of any person residing in this state on petition of the person filed in the county in which he or she resides. Before the court hearing on a petition for a name change, the petitioner must have fingerprints submitted for a state and national criminal history records check, except if a former name is being restored.
